STANDARD TERMS AND CONDITIONS

1. With the Customer's issuance of an order (contract) and SPS Technologies' acknowledgement of same order, the Customer and SPS Technologies agree to resolve any differences between the RFQ and the order at any time during the contract review and planning processes. Resolutions will be expedited if the Customer clearly identifies these differences when issuing the order.
2. Unless otherwise required, SPS Technologies operates to the following:
 - a. AS9100 Aerospace Standard and NADCAP approved procedures for applicable special processes.
 - b. Industry standards AS5447, NASM25027 and NAS4007 for applicable product, in the absence of customer defined Non Destructive Testing (NDT) acceptance criteria.
 - c. The latest standard and specification revisions in effect, and approved in the SPS Technologies document control system, at the time of the order. This also applies to supersession's to cancelled specifications, unless documented as an exception on the order. In cases where cancelled specifications provide no supersession, SPS Technologies conforms to widely accepted industry standards.
3. If insufficient engineering/quality information is provided with the order, SPS Technologies reserves the right to delay the delivery date from that promised. The delay may be the same number of days as are required to obtain a purchase order amendment with information SPS Technologies deems sufficient.
4. Any exceptions stated on the SPS Technologies quote should be listed on the order.
5. All changes (including but not limited to) engineering / quality requirements (e.g. ASQR, Material Control Lab, quality performance clauses), schedule, etc. shall be submitted through SPS Technologies Sales for evaluation of impact. The review shall be accomplished within 20 working days from acknowledged receipt.
6. Limited Warranty and Exclusive Remedy –
SPS Technologies warrants that these products conform to industry standards specified herein and will be free from defects in materials and workmanship. THIS WARRANTY IS EXPRESSLY GIVEN IN LIEU OF ANY AND ALL OTHER EXPRESS OR IMPLIED WARRANTIES, INCLUDING ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, AND IN LIEU OF ANY OTHER OBLIGATION ON THE PART OF SPS TECHNOLOGIES. SPS Technologies will, at its option, repair or replace free of charge (excluding all shipping and handling costs) any products which have not been subject to misuse, abuse, or modification and which in its sole determination were not manufactured in compliance with the warranty given above.
